The bidder shall furnish, as part of his **Bid security** i.e. Earnest money in any form as prescribed in Bihar financial rule and duly endorsed/pledged by the competent postal authority in Bihar (for a to e) to The Executive Engineer, Bihar Police Building Construction Corporation, Patna division in any of the following shapes or combination thereof:-


23. Eligibility criteria for downloading of tender document:-


Interested Bidders / Contractors who fulfill following eligibility criteria shall be eligible to apply:-

- (i) Any contractor registered with Central Govt./any State Govt. or any PSUs. or any agency of international or national repute may give the tender but registration in proper grade in Bihar Police Building Construction Corporation will be essential after issue of L.O.A. and before execution of agreement.
- (ii) Bidders are required to upload scanned copies of following documents at the time of submission of bid. In case of other State PWD/CPWD any PSUs. Eligible contractors or agencies of international/ national repute following documents (from a to c) have to be submitted after L.O. A. and before execution of agreement.
  - (a) Registration paper renewed.
  - (b) G.S.T. registration.
  - (c) Power of attorney/ Partnership deed/ MoU of Pvt. Company.
  - (d) Bank draft of B.O.Q. cost.
  - (e) Pan card.
  - (f) The evidence of arrangements of tools and plants by hire/lease/buying voucher of ownership of Batch Mix Plant of adequate capacity or evidence of its arrangement of possessing on hire/lease certificate required in aforesaid work duly verified by Divisional Engineer/ other State PWD contractor will provide definite proof from appropriate authority for Tools & Plants and undertaking to install it on work site after getting letter of acceptance to be attached with the tender itself.
  - (g) Documentary proof as the voucher of ownership of Batch Mix Plant or lease of Batch Mix Plant of adequate capacity is to be attached with tender. In absence of it the tender is liable to be rejected. All P.C.C. / R.C.C. work are to be done from Batch Mix Plant.
  - (h) Other Terms & Conditions of S.B.D. will be applicable.
- (iii) Bidders / Contractors should have achieved in any one year a minimum annual financial turn over ( in all classes of civil engineering construction work only), volume of construction work of the amount equal to the 50% (Fifty Percent) of estimated cost of work for which bid has been invited. The turnover will be indexed at the rate of 8% for a year.
- (iv) Bidders / Contractors should have satisfactorily completed as a prime contractor (or as a nominated sub contractor where, the sub-contract involved execution of all main items of work described in the bid document, provided further that all other qualification criteria are satisfied) at least on similar work value not less than 50% (Fifty percent) of estimated value of contract for which bid has been invited.
- (v) "Similar Civil Work" shall mean a project comprising of works Institutional building or, residential buildings along with services like plumbing, electrical, HVAC etc., of Central / State Govt. and PSU Sector /private sector on production of supporting documents and Completion certificate issued by Employer / C.A. certificate duly supported by balance sheets and architect certification in case of private sector shall be valid.

(vi) **Bidding capacity:-**

Bidders who meet the minimum qualification criteria will be qualified only if their available bid capacity is more than the total bid value. The available bid capacity will be calculated as under.

- (a) Assessed Available Bid Capacity =  $(A \times N \times 3 - B)$ . Where, A=Maximum Value of Civil Engineering works executed in any one year during the last 5 financial years up to March, 2017 ( updated to the price level of the year indicated in appendix) taking into account the completed as well as work in progress.

N= Number of years prescribed for completion of work for which bids have been invited  
B= Value (updated to the Price level of the year indicated in appendix to ITB) of existing commitments and ongoing works to be completed during the next ten months/ period of completion of work for which bids have been invited.

The statements showing the value of existing commitments and ongoing works as well as the stipulated period of completion remaining for each of the works listed should be countersigned by the Engineer-in-charge, not below the rank of executive engineer or equivalent.

- (vii) The contractor or his identified sub contractor should possess required valid electrical license for executing the building electrification works and should have executed similar electrical works for a minimum amount as indicated in Appendix to ITB in any one year.
- (viii) (a) Sub-Contractor's experience and resource shall not be taken into account in determining the Bidders compliances with qualifying criteria except to the extent stated in Para 23 (iv) above.  
(b) The contractor or his identified sub contractor should possess required valid license for executing the water supply/sanitary engineering works and should have executed similar water supply/sanitary engineering works for a minimum amount as indicated in appendix to ITB - in any one year.  
(c) The rate of all N.S.I. items must be quoted (zero or vague rates must not be quoted) by contractor at specified place, in absence of it the tender is liable to be invalid.
- (ix) **Joint Venture:-**

**Joint venture is permitted, subject to fulfillment of the following criteria:-**

- (a) In so far as consortium/ joint venture is concerned the same may be permitted. However only two or three partners shall be allowed in which any partner should have constructed a Institutional campus project on composite basis (civil works along with services like plumbing, electrical installation and supply, HVAC etc.) having total built-up area not less than 25000 Sq-m. or more in last 5 years up to 31-03-2018 with Completion certificate issued by Employer shall be valid.
- (b) Lead partner should have completed one similar work in the last 5 years up to March, 2018 of the cost not less than the amount equal to 60% of the estimated cost put to tender and other partner should have completed one similar work in the last 5 years up to March, 2018 of cost not less than the amount equal to 40% of the estimated cost put to tender. The financial turn over criteria can be jointly meet by the joint venture partners. However the share of lead partner should be at least 50% and for other partner it should be at least 25% and should jointly fulfill the 100% criteria.
- (c) The successful joint venture bidder will have to form a company under Company Act, before issue of letter of acceptance. This company would get into agreement with BPBCC for the execution of the work.

24. Agreement shall be done with the successful Bidder on prescribed agreement form., which is available as a Govt. of Bihar Publication. Bidder shall quote his rates as over all percentage above/below/ at PAR the amount of B.O.Q.
