Any Contractor Registered with Central Government / Any State Government / Any Public Sector Undertakings or any Agency or Original Manufacturer of National or International repute may tender, but Registration with Bihar Police Building Construction Corporation, Patna will be essential after issue of Letter of Acceptance. Any contractor debarred from work or blacklisted will not be allotted the work.
12. It is mandatory to conduct a mock-up for the items at **Head Quarter of BPBCC** before the supply is made. Only if the quotationer fulfill the minimum technical qualification requirements. This allows the concerned officers to inspect the items in advance and ensure they meet the required standards and specifications.
13. The financial bid will be opened only of successful tenderers in the mock-up & technical bid. In a financial bid the lowest / minimum quotation bidder will be have to obtain approval for the furniture from the authorized officer/ representative at the corporation head quarters & the authorized officer of the administrative department.
14. If selected quotationer are from outside the Bihar, then tenderer shall be required to establish a regional office in Patna to facilitate regular monitoring & ensure smooth coordination.

16. Bidder desiring to participate in the tender shall have to get registered with e-procurement. Necessary registration forms are available at the website. Bidder will get user id and password by registration. Bidder shall have to obtain DSC (Digital Signature Certificates) also. Bidder shall be able to participate in tender using user id, password, DSC and internet.
17. Bidder shall have to obtain (download) tender papers and submit (upload) their bids only at the website. Prescribed forms filled up at specified places and necessary documents shall be submitted. Information regarding tender opening or any corrigendum regarding tender shall be available at the website <https://bpbcc.bihar.gov.in> only.
